#### What is the Therapeutic Intervention Program (TIP)?

- TIP is a District-wide mental health support program.
- TIP provides a high-level intensive support for students with or without a documented mental health diagnosis.
- This is a collaborative effort involving educators, case managers, families, students, and community providers.
- The program is a small support community to encourage students to safely deal with mental health issues while learning social and academic skills
- TIP is structured in its overall goal to reintegrate students back into the traditional classroom setting.
- TIP is sensory-based, and the environment is designed to promote a sense of calmness. The use of kinetic sand, aromatherapy, weighted animals, dimmed lights, tranquil music, and projectors as well as alternative seating is integral to creating an environment unique to TIP.
- TIP is highly individualized for each student.
- TIP is a place where mental health is de-stigmatized and mental wellness is promoted. Everyone is on a journey and that journey is honored.

• It is not a **Behavioral Unit.**

Remember that all advocates will begin with a clean CEU slate on **January 1**, **2019**. Your supervisor will track your CEUs by the calendar year instead of the date you were sworn in as a CASA. Each advocate needs to gain 12 hours of continuing education by December 31, 2019.

Books, movies, videos, perhaps even conferences through your church or work can all be used as credits if they connect with your role as a child advocate. Google National and Texas CASA for videos and webinars that are not only

up to date and helpful but can be painlessly completed in your own home. And, of course, CASA Café and Lunch and Learn events are scheduled frequently with local resources who are invaluable as we pursue our CASA cases.
