#### **Advocacy—What Does it Cost?**

- Becoming a CASA volunteer is an investment of time, energy and heart. But as many volunteers
  have said of the children they worked with: "It wasn't about what I gave them; it was what they
  showed me."
- Most CASA volunteers spend an average of 10-15 hours per month on their case, including visits, phone calls, e-mails, documentation, and court appearances. Some months during the life of the case are more time-consuming than others.
- National CASA requires that all volunteers receive a minimum of 30 hours of pre-service training as well as court observation hours.
- Additionally, volunteers are required to complete 12 hours of in-service training per year. As in any professional setting, policies and laws change and new ways of "doing business" appear periodically. Effective CASA volunteers need to stay current with changes in Family Law, CPS policies, child development studies, and a host of other updates to help us be the best advocates we can be...for children who deserve nothing but our best. If you are not current on your CEUs, remember that many opportunities exist to meet this requirement. Books, movies, videos, perhaps even conferences through your church or work can all be used as credits if they connect with your role as a child advocate. Google National and Texas CASA for videos and webinars that are not only up to date and helpful but can be painlessly completed in your own home. And, of course, CASA Café and Lunch and Learn events are scheduled frequently with local resources who are invaluable as we pursue our CASA cases.
- SOMETHING NEW: Texas CASA is the guideline for our CEU requirements; recently, the time
  frame for accruing CEUs has changed. Big Country CASA will now track advocate CEUs by the
  calendar year. So, CEU documentation will begin on January 1, 2019: each advocate needs to
  gain 12 hours of continuing education by December 31, 2019. Call the office and speak to Rebel if
  you have questions about your CEUs.

Don't let these opportunities pass you by...and don't lose your connection with CASA because you aren't up to date with continuing education!

**CONFIDENTIAL COMPANION TRAINING:** There are still openings for the next training on October 23, 2018 from 5:30 to 8:30 p.m. at our CASA offices. This three-hour training will allow a spouse or friend to accompany the CASA as you work your case. Notify the office for an application.
