3 simple steps of the IEP process

The IEP process in a nutshell:

- determine needs (evaluations)
- draw up goals, strategies, and services to meet those needs and reach goals
- determine placement based on where the strategies and services can best be implemented

Can the child stay in their current placement and still have their needs met? I have seen some districts and staff do some really crazy (in a good way!) and out-of-the box thinking when it comes to accommodating a child. Those people are rare, from my experience. Our special ed system is in crisis and we are in what I call the "culture of no." Districts just say no over and over and over to wear you down, hope that you go away. Don't go away. Keep fighting and keep advocating.

Congratulations to Evette Orren, named Volunteer of the Quarter for Summer 2019. Her BCC supervisor, Rob Marcelain, presented Evette to the Board of Directors: Evette has been a CASA since 2017 and is currently working on her third case. Evette's current case is a young girl who was sexually abused by her father for a number of years. She was isolated from society and "homeschooled" for several years. Her schooling consisted of watching the same videos over and over. Evette used her former profession and connections in the AISD to get the girl tested to see exactly what her education level was and what help she would need when the new school year began. Evette has spent time with this girl on outings to help reintroduce her to society.

When you get a new case, or make a visit to your child on a case you are already working, don't forget to stop by the office and pick up a handmade quilt, a book or two, or a stuffed animal or toy for your child(ren).

Domestic Violence Awareness Month in Abilene Begins with Candlelight Vigil

Thursday, Oct. 3, 7 - 8 p.m. Front Steps of the Taylor County Courthouse

Noah Project will begin a month-long series of events and activities to commemorate Domestic Violence Awareness Month with a candlelight vigil to remember domestic violence victims killed by their abusers during the last year. Abilene Mayor Anthony Williams opens the event by issuing and reading a proclamation against domestic violence in Abilene.

During the vigil, **Noah Project** staff will name each victim who died at the hands of their abuser, then read a poetic testimony from a victim of domestic violence. Materials will be provided for attendees to write letters of encouragement to victims of domestic violence and sexual assault currently in resident at Noah Project's shelter. Attendees can also contact state lawmakers with pre-printed postcards asking to strengthen laws for the benefit of domestic violence victims.

All participants are encouraged to **wear purple** – the color of Domestic Violence Awareness Month. The event is free and open to the public. No advanced registration required.
