QUALITY ASSURANCE REVIEW

As you may know, our program recently went through a QA Review with Texas CASA at the first of December. There were around 100 standards reviewed along with other Texas Administrative Code requirements. We have received the final report and are happy to report there were no findings which means we clearly passed. This is simply not possible without dedicated volunteers, staff and board members keeping the bar held high. Congratulations to all and thank you for your commitment to children and families. During the review, the Program Specialist evaluated: 12 randomly selected child files, 4 randomly selected volunteer files, 2 employee files, 12 months of board meeting minutes with attachments, and 3 months of bank statements.

Safety advocacy communication and documentation – 100%


Communication of documented educational advocacy – 100%

16+ ADVOCACY

To assist youth in preparing for adulthood, special attention should be given to the needs of the youth to set them up for success. Case files with youth 16+ had documentation of requesting the youth's drivers license, birth certificate and SS card, and then a follow-up to confirm the documents were received by the child.

COLLABORATIVE FAMILY ENGAGEMENT (CFE)

This promising practice emphasizes connection and community for children and families. Big Country CASA begins teaching CFE in Pre-service Training. Volunteers are provided a "red folder" that includes a list of community services, case acceptance and CFE information. Volunteers are encouraged to conduct a CFE tool on their first visit with a child.

BOARD MEETINGS

In FY22, the board met the quorum 100% of the time with a yearly average of 71% attendance at the meetings.

STRATEGIC PLAN FOR 2023-2028

- Achieve and maintain fiscal responsibility within the organization via fund development allowing any surplus added to reserves or endowments.
- 2. Continue pursuit of BCC's goal to serve 100% of the children in Taylor County who need a CASA.
- 3. Grow the Volunteer Pool by 20% annually.
- 4. Diversify staff, volunteers, and governing board to reflect the population and meet the needs of the children served by 30%.
